## **HEALTH POLICY UPDATE: November 15, 2022**

## **Congressional Schedule:**

• The Senate convenes at 11 a.m. Following leader remarks, the Senate will resume consideration of the nomination of Maria del R. Antongiorgi-Jordan to be a U.S. district judge for the District of Puerto Rico. The Senate will recess from 12:30 p.m. to 2:15 p.m. for weekly caucus lunches. At 2:15 p.m. the Senate will vote on confirmation of the Antongiorgi-Jordan nomination.
