# **HEALTH POLICY UPDATE: November 29, 2022**

# **Congressional Schedule:**

- The Senate convenes at noon. Following leader remarks, the Senate will resume consideration of the Respect for Marriage Act (HR 8404). The Senate will recess from 12:30 p.m. to 2:15 p.m. for weekly caucus lunches. At 3:45 p.m., the Senate will conduct up to two minutes of debate prior to each amendment, if offered, and vote on the following in the order listed: adoption of the Lee, R-Utah, amendment no. 6482, with a 60-vote affirmative threshold; adoption of the Lankford, R-Okla., amendment no. 6496; adoption of the Rubio, R-Fla., amendment no. 6493; adoption of the Schumer, D-N.Y., for Baldwin, D-Wis., substitute amendment no. 6487, as amended, if amended; and passage of HR 8404, as amended, with a 60-vote affirmative threshold. Following disposition of HR 8404, the Schumer motions to invoke cloture on the following nominations will ripen: Camille L. Velez-Rive to be U.S. district judge for the District of Puerto Rico and Anne M. Nardacci to be U.S. district judge for the Northern District of New York.
