## **HEALTH POLICY UPDATE: December 13, 2022**

## **Congressional Schedule:**

• The Senate convenes at 10 a.m. Following leader remarks, the Senate will resume consideration of the nomination of Dana M. Douglas to be a U.S. Circuit Judge for the 5th Circuit. At noon, the Senate will vote on confirmation of the Douglas nomination. The Senate will then recess until 2:15 p.m. for weekly caucus lunches. At 2:15 p.m., the Senate will vote on confirmation of the nomination of Jay Curtis Shambaugh to be an undersecretary of the Treasury. At 3:30 p.m., the Senate will begin debate on a motion to discharge the Yemen war powers resolution (S J Res 56) from the Senate Foreign Relations Committee, with time equally divided until 7 p.m., at which point the Senate will vote on agreeing to the motion to discharge S J Res 56.

- Jay Curtis Shambaugh to be an undersecretary of the Treasury.

- The House reconvenes at noon for legislative business and is expected to consider measures under suspension of the rules. The chamber is also expected to consider a bill (HR 3648) that would remove the current per-country cap on certain employment-based visas. And the House may take final votes on bills previously debated under suspension of the rules.
