HEALTH POLICY UPDATE: JUNE 16, 2022

Congressional Schedule:

- The Senate convenes at 10 a.m. Following leader remarks, the Senate will resume consideration of the veterans' toxic exposure benefits bill (HR 3967). At 11:15 a.m., the Senate will vote on the following: passage of HR 3967, as amended, agreeing to the Schumer, D-N.Y., motion to invoke cloture on the nomination of Ana Isabel de Alba to be a U.S. district judge for the Eastern District of California, and agreeing to the Schumer motion to invoke cloture on the nomination of Mary T. Boyle to be a commissioner of the Consumer Product Safety Commission.
